1.2. AIRPORT FACILITIES

1.2.2. Storage

At Agents Bond Store. Time limit 14 days. Thereafter goods will be transferred to Queen's Warehouse. Time limit 3 month.

Cold storage: Not available.

Safe for valuables: Available.

Room for radio-active material: Not available.

1.2.3. Clearance

In Agent's Town Terminal by consignee or broker. At the airport after prior Customs permission only.

1.2.4. Customs hours

Monday through Friday 08.00 - 12.00 hrs. and 13.00 - 16.30 hrs.

Clearance outside Customs hours possible after prior permission from Customs and against payment of overtime fee.

1.2.5. Delivery

Only possible through an agent.

1.2.6. (Re)-Forwarding

By air, boat or mail. Re-forwarding under bond only by Solomon Airlines to destinations with Customs Officer (i.e. Gizo and Munda).

All goods must indicate country of origin.

2.2. DOCUMENTARY REQUIREMENTS

2.2.1. Commercial consignments

- 2 "Combined Certificates of Value and of Origin and Invoice of Goods".

- Import Licence for some articles.

2.3. RESTRICTIONS

2.3.2. Live animals

Health Certificate must be issued by Country of Export. Import Permit is obtainable from Director of Quarantine, P.O. Box G13, Honiara, Solomon Islands.

2.3.3. Plants and plant material

Phytosanitary Certificate must be issued by Country of Export. Import Permit is obtainable from Director of Quarantine, P.O. Box G13, Honiara, Solomon Islands.

2.5. CHARGES

2.5.2. Handling

Terminal Charges:

Shipments more than 100 kg., per kg. 0.70

Minimum charge for shipments less than 100 kg. 70.00

2.5.6. Storage

First 3 working days free.

0 - 50 kg., per day 30.00

51 - 100 kg., per day 55.00

More than 100 kg., per day 100.00

Three (3) free working days storage limit applies to all consignments.

Above fees applying after this period. Charges after this period will be per day or part thereof.
